





Biennial Revenue Estimate (BRE) in Numbers


BRE provides assumptions on the growth of Texas economy and revenue for the next 2.5 years and includes:

- nearly 200 estimates of various economic indicators,
- more than 1,400 estimates of various revenues, and
- estimates of nearly 400 balances in various funds and accounts.

Texas Monthly Employment (Jan. 2010 – Oct. 2024)




Monthly Unemployment Rate, TX and US (Jan. 2010 – Oct. 2024)





Cumulative Employment Percent Change from 2019




YoY Employment Percent Change, Selected Sectors


