## TTARA Honors Marty Loeber with the Del Threadgill Distinguished Tax Professional Award

**Austin, TX** – The Texas Taxpayers and Research Association (TTARA) proudly announced that Marty Loeber, Senior Vice President of Ad Valorem Tax for Valero in San Antonio, has received the prestigious Del Threadgill Distinguished Tax Professional Award during TTARA's 2025 Annual Meeting on November 20. This award, presented annually since 2011, is TTARA's highest honor, recognizing individuals who have made significant contributions to advancing fair state and local tax policy, demonstrated exceptional professionalism, and earned the respect of their peers as leaders in the field.

The award is named in honor of the late Delmer Ray Threadgill, former Chairman of TTARA and Vice President and Director of Tax Services at J.C. Penney Company.

Marty Loeber has been a long-time member of TTARA, actively participating in various committees and serving as a dedicated board member. In his 28 years at Valero, the world's premier independent refiner, Marty has held a range of leadership roles. He began his career in legal, overseeing litigation, and later managed legal affairs and commercial marketing for Valero's UK/Ireland operations. Since 2018, he has led Valero's property tax function and oversees its foreign trade zone operations.

Licensed as a Texas lawyer, Marty also serves on the board of CalTax, the California taxpayer advocacy group. His commitment to community service includes past leadership as Board Chair of SAMMinistries, a leading homeless charity in San Antonio, and current service on the board of the Women's Storybook Project of Texas. He holds both a bachelor's degree and a law degree from Baylor University.
